## **Risk Assessment Policy**

Including those in the EYFS (Early Years Foundation Stage)

### Introduction

A Risk Assessment is a tool for conducting a formal examination of the harm or hazard to pupils, staff, the school that could result from an activity or situation.

### Definition

- A hazard is something with the potential to cause harm
- A risk assessment is an evaluation of the probability (or likelihood) of the hazard occurring and putting in control measures to ameliorate the risk

### Objectives

- To ensure that risk assessments are undertaken for activities both in school where there is likely to be significant risk
- To ensure that risk assessments are undertaken for activities out of school
- That identified control measures are implemented to control risk as far as reasonably practicable
- That those affected by school activities have received suitable information on what to do
- That risk assessments are recorded and reviewed when appropriate.

### **Method of Recording**

- Risk Assessments are completed by the member who is leading the activity or whose area of responsibility it is within the school.
- Risk Assessments must be completed on the standard school format.
- Risk Assessments must be written in a timely manner so that they can be read by the Head Teacher and adapted, if necessary,
- All Risk assessments must be signed off by the Head Teacher.

### Review

The Risk Assessment Policy, its contents and its effectiveness will be reviewed annually by the Head Teacher and other members of the SMT. The findings of this meeting will be discussed with the governors.

### Staff Training

Staff will be trained annually on the school's risk assessment policy and procedures.
